The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of the Plan assets, after subtracting liabilities of the Plan, were \$224,106,253 as of the end of plan year, compared to \$207,160,025 as of the beginning of the plan year. During the Plan year the Plan experienced a change in its net assets of \$16,946,228. This change includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan year, the Plan had a total income of \$41,486,257 including employer contributions of \$18,796,695, employee contributions of \$6,116,486, and earnings from investments of \$16,573,076. Plan expenses were \$935,689. These expenses included \$70,989 in administrative expenses, \$864,700 in benefits paid to participants and beneficiaries.

Basic Financial Statement

The value of the Plan assets after subtracting liabilities of the Plan were \$475,977,091 as of the end of plan year, compared to \$400,655,758 as of the beginning of the plan year. During the Plan year the Plan experienced a change in its net assets of \$75,321,333. This change includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan year, the Plan had a total income of \$66,768,053 including employer contributions of \$34,402,010, and earnings from investments of \$32,366,043. Plan expenses were \$15,051,060. These expenses included \$126,701 in administrative expenses and \$14,924,359 in benefits paid to participants and beneficiaries.

This is a summary of the annual report for The Dow Chemical Company Employees' Savings Plan (Employer Identification Number 38-1285128, Plan Number 002) for the plan year 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$1,061,671,783. These expenses included \$3,204,847 in administrative expenses and \$1,057,570,066 in benefits paid to participants and beneficiaries, \$246,119 in certain deemed and/or corrective distributions, and \$650,751 in other expenses. A total of 35,803 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, were \$11,502,338,834 as of the end of the plan year, compared to \$10,913,979,302 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$588,359,532. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,653,516,647, including employer contributions of \$2,578,875, employee contributions of \$215,067,630, other contributions/other income of \$111,801,150, gains/(losses) of -\$33,008,077 from the sale of assets, and earnings from investments of \$1,357,077,069.
