UCC has committed itself to pay certain HMO contract benefit claims incurred under the terms of the plan.

This is a summary of the annual report of THE DOW CHEMICAL COMPANY RETIREMENT HEALTH CARE ASSISTANCE PLAN FOR ACTIVE EMPLOYEES, a health, severance pay and death benefits plan (Employer Identification Number 38-1285128, Plan Number 540), for the plan year January 1, 2021 through December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Basic Financial Statement**

The value of the Plan assets, after subtracting liabilities of the Plan, were \$226,862,026 as of the end of plan year, compared to \$224,106,253 as of the beginning of the plan year. During the Plan year the Plan experienced a change in its net assets of \$2,755,773. This change includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan year, the Plan had a total income of \$42,210,555 including employer contributions of \$5,325,120, employee contributions of \$21,420,400, and earnings from investments of \$15,465,035. Plan expenses were \$1,540,292. These expenses included \$80,094 in administrative expenses, \$1,460,198 in benefits paid to participants and beneficiaries. During the plan year, assets of \$37,914,490; were transferred to this plan from The Dow Chemical Company Retirement Health Care Assistance Plan for Retirees.

The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

The value of the Plan assets after subtracting liabilities of the Plan were \$553,366,535 as of the end of plan year, compared to \$475,977,091 as of the beginning of the plan year. During the Plan year the Plan experienced a change in its net assets of \$77,389,444. This change includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the Plan year, the Plan had a total income of \$59,782,838 including employer contributions of \$28,174,057, and earnings from investments of \$31,608,781. Plan expenses were \$20,307,884. These expenses included \$166,728 in administrative expenses and \$20,141,156 in benefits paid to participants and beneficiaries. During the plan year, assets of \$37,914,490 were transferred to the plan from The Dow Chemical Company Retirement Health Care Assistant Plan for Active Employees.

This is a summary of the annual report for The Dow Chemical Company Employees' Savings Plan (Employer Identification Number 38-1285128, Plan Number 002) for the plan year January 1, 2021 through December 31, 2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Basic Financial Statement**

Benefits under the plan are provided by a trust fund. Plan expenses were \$1,323,533,711. These expenses included \$3,421,637 in administrative expenses and \$1,319,731,058 in benefits paid to participants and beneficiaries, \$99,278 in certain deemed and/or corrective distributions, and \$281,738 in other expenses. A total of 34,607 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, were \$11,824,972,858 as of the end of the plan year, compared to \$11,502,338,834 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$322,634,024. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,650,095,720, including employer contributions of \$7,572,135, employee contributions of \$216,295,522, other contributions/other income of -\$10,263,091, gains/(losses) of \$127,934,087 from the sale of assets, and earnings from investments of \$1,308,577,067.
