Subject: Notification of changes of the Dow Olefinverbund GmbH

Dear valued customer,

As mentioned in our February 2025 letter, we want to keep you updated on Dow's reorganization of Dow Olefinverbund GmbH. This communication confirms the dates of changes which will take effect on May 1, 2025.

Dow Olefinverbund GmbH will transfer the administration and operation of its Industry Parks in Schkopau and Böhlen to InduServ SB GmbH & Co. KG, a wholly owned subsidiary of the Dow Olefinverbund GmbH, which will continue to manage the Industrial Park.

As part of this transfer, all in-scope customer and supplier contracts will be assigned to InduServ SB GmbH & Co. KG with all rights and obligations. If you have a contract effected by this change which will either be fully or partially assigned, you will receive a separate notification with further details.

All services provided prior to April 30, 2025 by Dow will continue to be invoiced by and should continue to be paid to the Dow Olefinverbund GmbH legal entity. After the transition to InduServ SB GmbH & Co. KG on May 1, 2025, the following invoice and remittance details will apply to your orders. Please see Addendum A for more details.
